ORDER

The proposal in respect of Mother Theresa Memorial Central School, Pulippara, Pangodu P.O, Kallara, Thiruvananthapuram has been recommended and forwarded by the Director of Public Instructions as per his letter read above along, with the visit report of the District Educational Officer, Attingal. As per the letter read above the District Educational Officer, Attingal has reported that a petition regarding the encroachment of School management to the nearby land has been received and cases thereof are pending with the Munsiff Court, Nedumangad.

After having examined the matter in detail, Government are pleased to issue NOC for CBSE affiliation in respect of Mother Theresa Memorial Central School, Pulippara, Pangodu P.O, Kallara, Thiruvananthapuram which is found eligible as per the guidelines in the Government Order read as 3rd paper above, subject to the disposal of OS pending before the Munsiff Court, Nedumangad.
